Proclamation

I, Maggie Toulouse Oliver, New Mexico Secretary of State, by virtue of the authority vested in me, do hereby issue the following proclamation:

That a Municipal Officer Election is called to be held in applicable municipalities throughout the State of New Mexico and precincts thereof on March 3, 2020; and

That a Municipal Officer Election shall be a nonpartisan election, and the names of all candidates shall be listed on the ballot with no party or slate designation; and

That all municipalities, where applicable, shall conduct the runoff election pursuant to Section 1-22-16 NMSA 1978; and

That the City of Gallup shall conduct a top-two runoff election following the Municipal Officer Election, should one be necessary. If a top-two runoff election is necessary, it will be held on March 31, 2020; and

That the City of Hobbs shall conduct a top-two runoff election following the Municipal Officer Election, should one be necessary. If a top-two runoff election is necessary, it will be held on April 14, 2020; and

That the City of Las Vegas shall conduct a top-two runoff election following the Municipal Officer Election, should one be necessary. If a top-two runoff election is necessary, it will be held on April 14, 2020; and

That the City of Rio Rancho shall conduct a top-two runoff election following the Municipal Officer Election, should one be necessary. If a top-two runoff election is necessary, it will be held on April 7, 2020; and

That a Municipal Officer Election shall be held to elect municipal officers for the following offices:
