



## NOTICE OF ADOPTION OPEN MEETINGS RESOLUTION 24-01

**NOTICE IS HEREBY GIVEN** that on January 23, 2024, the Town of Taos Council, at their Regular Meeting at 4:00 p.m., adopted Open Meetings Resolution 24-01.

The Town Council of the Town of Taos, New Mexico, will hold their hybrid Regular Meetings on the second and fourth Tuesday of every month at 4:00 p.m. at the Town Council Chambers, Coronado Hall, 120 Civic Plaza Drive, Taos, New Mexico, *except for* December 24, 2024, when the Town of Taos is closed due to a scheduled holiday.

Town Council hybrid Workshop Meetings are held on the fourth Monday of the month at 4:00 p.m. at the Town Council Chambers, Coronado Hall, 120 Civic Plaza Drive, Taos, New Mexico, **except for** May 27, 2024, when the Town of Taos is closed due to a scheduled holiday.

Town Council Community Workshop Hybrid Meetings are held quarterly at 5:00 p.m. at the Town Council Chambers, Coronado Hall, 120 Civic Plaza Drive, Taos, New Mexico. Community Workshop Meetings are scheduled on March 11, 2024, June 10, 2024, September 9, 2024, and December 9, 2024.

Hybrid Special Meetings of the Town Council may be called by the Mayor or by request of a majority of the Town Council upon seventy-two-hour notice to the Mayor, members of the Town Council, and the public. Special meetings shall be held at the date, time and place set forth in the notice of the special meeting.

Hybrid Emergency Meetings of the Town Council may be called by the Mayor or by request of a majority of the Town Council under unforeseeable circumstances which require immediate action by the Town to protect the health, safety and/or property of the Town or persons within the Town, or which require immediate action by the Town to prevent substantial financial loss to the Town. Emergency meetings may be called upon twenty-four (24) hours' notice to the members of the Town Council, unless threat of personal injury, property damage or financial loss requires less notice. Said meetings shall be held at the date, time, and place set forth in the call of said emergency meeting.

A meeting or a portion of a meeting may be closed to the public only if the subject matter of such discussion is exempt from the open meeting requirements under Section 10-15-1(H) of the Open Meetings Act.
